Withdrawals

- Lake Lindero Country Club Summer Sports Camp reserves the right to dismiss any Camper whose conduct is dangerous, illegal or, at the discretion of the Camp Director, is detrimental to the Camp and/or other Campers.

Personal Belongings

- Lake Lindero Country Club is not responsible for any personal belongings lost, stolen or damaged. I understand that Lake Lindero Country Club discourages bringing electronic games, phones or other expensive belongings.
- **Campers are responsible for providing their own lunch. Should campers forget to bring a lunch, Lake Lindero Country Club will provide a lunch at an additional \$10/day charge.**

AGREEMENT, WAIVER, AND RELEASE:

In consideration for being permitted by Lake Lindero Country Club (LLCC) to participate in the Sports Camp, I hereby waive, release, and discharge in advance LLCC (their officers, employees, and agents) from any and all liability arising out of or connected in any way with my participation in camp activities, including the active or passive negligence of each of the named above or any other participants in the event. The parties to this AGREEMENT understand that this document is not intended to release any party from any act or omission or "gross negligence," as that term is used in applicable case law and/or statutory provision. It is understood that these activities involve an element of risk and danger of accidents and knowing those risks I hereby assume those risks. It is further agreed that this waiver, release, and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold the above person or entities free and harmless from any loss, liability, damage, cost, or expense which they may incur as the result of my death or any injury or property damage that I may sustain while participating in said activities. **Note: LLCC assumes no liabilities for food allergies when providing lunches. Please do not participate in the lunch program if food allergies are a concern.**
